### Major Violations

**Inspector Observations: Steel glass in use to scoop cheese at the prep table.**

**[CA] Use scoop/glass with a handle in such a way that the handle does not come in direct contact with food to prevent contamination.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: Mop was left on the side of the 3-comp sink and mop handle was touching the dirty containers.**

**[CA] After use, mop shall be stored in a mop room.**

**Baskin Robin ice cream and Aloe vera drinks was stored in a freezer with pepperoni.**

**[CA] Employee shall not store personal beverage and ice cream with the restaurant food..**
