Major Violations

No major violations were observed during this inspection.

Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations:

Quaternary ammonium sanitizer in the 3 compartment sink was measured at 100 ppm. Per employee, the auto dispenser dispenses the concentration a bit high so they have to dilute with water.

[Corrective Action] Maintain quaternary ammonium sanitizer concentration at 200 ppm.

[Corrected on Site] Employee adjusted the concentration to 200 ppm.

K47 - 2 Points - Signs not posted; last inspection report not available; 113725.1, 113953.5, 113978, 114381(e)

Inspector Observations:

Health permit not displayed in public view.

[Corrective Action] Display the current valid health permit in public view.
