Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

Inspector Observations: Measured quat sanitizer concentration greater than 400ppm in sani bucket for wiping cloths. [CA] Maintain quat sanitizer concentration at 200ppm or as specified by manufacturer in sanitizer bucket holding wiping cloths.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Drain pipe from soda machine is inside floor sink without air gap. [CA] Provide a minimum one inch air gap between end of soda machine drain pipe and flood level rim of floor sink.
