The following violation was corrected:

K23M - COCKROACH INFESTATION

- *In the kitchen area, observed area around large upright freezer has been cleaned, and shelving around the freezer has been cleaned.*
- *Observed dead cockroaches on the floor around the facility. Continue to clean and sanitize facility to prevent any form of contamination.*
- *Observed several live cockroaches on monitoring traps placed in the kitchen area. Contact pest control to provide continued service to eliminate all activity.*
- *Follow-up inspection to occur within 2 weeks to ensure facility has been maintained and kept free of all live cockroach activity.*

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
