## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

#### **Inspector Observations:**

**\*REPEAT VIOLATION\***

***In the back of house area, at the hand wash station, the paper towel dispenser and soap dispenser are not operational.***

***[CA] All food facilities shall provide an operable handwashing station. Handwashing facilities shall be equipped with handwashing cleanser and single-use sanitary towels in dispensers.***

***[SA] Per staff they have been using the Front of House hand wash station. Note: The front of house hand wash station is fully stocked and operational.***

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

#### **Inspector Observations:**

***In the back of house area, at the hand wash station, the water is turned off. Per staff, they wash their hands at the front of house hand wash station. Note: Front of House hand wash station was observed fully stocked and operational.***

***[CA] Handwashing facilities shall be equipped to provide minimum 100°F water under pressure for a minimum of 15 seconds.***

K47 - 2 Points - Signs not posted; last inspection report not available; 113725.1, 113953.5, 113978, 114381(e)

#### **Inspector Observations:**

***The Environmental Health Permit is not posted within public view.***

***[CA] The health permit issued by this department shall be posted in a conspicuous place in the food facility.***
