Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: The handwash sink located back in the kitchen area was blocked by boxes of food products and a shelf.

[CA] Make the handwash sink easily accessible for employees to wash hand whenever it is necessary. The manager removed the boxes, and cleared the handwash station (COS).

Minor Violations

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Couple boxes of food products were stored directly on the floor or on milk crate back in the storage area.

[CA] To prevent insect hiding and breeding and for easy cleaning of the floor area, please store all food products at least six inches off the floor on approved shelf or dunnage rack.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The ceiling panels over mop sink area have an opening greater than 1/4 inch.

[CA] Repair gaps in structure and maintain in good condition to prevent pest harborage.
