Major Violations

No major violations were observed during this inspection.

Minor Violations

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: Observed employee washing hands in three compartment sink.

[CA] Hands shall be washed in available hand wash sink. Three compartment sink shall only be used for washing, rinsing and sanitizing dishes.

Observed two phones stored in middle prep table and one phone stored on back prep table.
