Overall Comments:

All prepackaged foods from Choice Lunch. Observed TPHC time-marking for hot and cold foods. TPHC written procedures were available.

Note: the newly installed mop sink and water heater still need to be finaled and approved by Plan Check (SR0878373). Contact Plan check and carry out any remaining requirements, and schedule prefinal/final inspections as needed.
