Major Violations

No major violations were observed during this inspection.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: Surface of coolers and freezers heavily stained [CA] Clean the units daily

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: Hood and hood filters show grease accumulation [CA] Clean the hood and hood filters

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

Inspector Observations: The digital probe thermometer is out of battery [CA] Maintain a working probe thermometer and take food temperatures daily

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Floor corners show buildup [CA] Clean the floor corners.

Area under the cooking equipment shows heavy grease buildup [CA] Clean area thoroughly
