Comments and Observations

Major Violations

K05 - 8 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

Inspector Observations: *Dishwasher observed to be handling clean dishes after handling dirty dishes without changing gloves and just quickly rinsing gloves hands. [CA] Wash hands with soap and warm water prior to handling any clean utensils or foods to prevent cross contamination. [COS] Dishwasher removed gloves and washed hands.*

Minor Violations

No minor violations were observed during this inspection.
