K07: Ambient air in the refrigeration units measured below 41 degrees F.

K06: Handwash sink has yet to be installed by the new owner. Employees are washing hands at the 2 compartment sink. [CA] Install a handwash sink. Operator indicated that a handwash sink will be installed by 06/10/2021.
