## **Major Violations**

K21 - 8 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: Measured the temperature of hot water at 73F in the restroom handsinks, kitchen/bar/wait station handsinks, dump sinks in bar, prep sink in kitchen, and 3-comp-sinks in bar & kitchen. [CA] Maintain hot water at a minimum temperature of 100F in all handsinks and at 120F in all other sinks (mop sink, dump sink, 3-comp-sink, prep sink).

Due to lack of proper hot water temperature facility is closed. Once this violation is corrected contact specialist for a follow up inspection.

# **CLOSURE / PERMIT SUSPENSION NOTICE**

When required to determine compliance, a single reinspection will be conducted without additional charge. This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
