FOLLOW UP INSPECTION FROM 10/12/23 IN WHICH THE SERVICE REFRIGERATOR WAS UNABLE TO KEEP THE POTENTIALLY HAZARDOUS FOOD AT 41F OR BELOW. ALSO, THE MEAL PLATES WERE NOT TIME MARKED TO REFLECT THE USAGE OF TIME AS A PUBLIC HEALTH CONTROL. IN ADDITION, YOGURT WAS MADE AT THIS FACILITY.

FINDINGS: THE REFRIGERATOR WAS REPAIRED, PER OWNER, HOWEVER, THE TEMPERATURE REFLECTS 45F. DO NOT USE THIS REFRIGERATOR. NOTE: THE OWNER STATES THAT HE WILL BUY A NEW REFRIGERATOR AND REPLACE THE OLD ONE:LIKE FOR LIKE.

THE MEAL PLATES HAVE A DATE AND TIME MARKING AND NO YOGURT MADE AT THIS FACILITY IS BEING RETAILED.

CONTINUE WORKING ON THE REST OF THE VIOLATIONS.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
