### Major Violations

**Inspector Observations: Measured bean sprouts, boiled eggs, tofu inside the 2 door prep unit between 45F-48F.**

**Observed double containers used for food, and containers were filled to the top.**

**[CA] Maintain potentially hazardous food 41F and below. Use single containers for better air flow and fill containers half way.**

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations: Observed raw beef and raw eggs stored above ready to eat food in 2 door food prep unit.**

**[CA] Store raw meat below ready to eat food.**
