Comments and Observations

Major Violations

K08 - 8 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: Lack of time marking for food on hot/cold buffet line. Chicken and ham measured between 85-95F, tofu at salad station (cold line) measured at 76F.

[CA] When time only, rather than time and temperature is used as a public health control, PHFs shall be time marked to indicate when item is removed from temperature control, discarded if not consumed or served within 4 hours, and written procedures shall be readily available for review.

[COS] Food was time marked on glass sneeze-guard

Minor Violations

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: Lack of sink and sanitizer/lactic acid test strips on site. Only quaternary ammonium test strips available. [CA] Provide the sink and sanitizer test strips.
