A re-inspection was conducted on this date to verify the abatement of the cockroach infestation resulting in closure observed during the 4/15/26 routine inspection.

On this date the following major violation was observed corrected:

K23 - Observed rodents, insects, birds, or animals:

No further evidence of cockroach activity was observed at this time.

The equipment/shelving contributing to the harborage of vermin have been removed from the facility. Affected areas have been cleaned and sanitized and fecal spotting in noted areas have been removed.

Pest control visits were conducted by Purcor on 4/15/2026 indicating a fogging of the facility and 4/16/2026. Continued treatment with Purcor will be conducted on a monthly basis.

This facility is hereby authorized to operate by this department. Continue to correct any remaining violations as noted during the routine inspection.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **5/1/2026**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
