Major Violations

Inspector Observations: FOUND EXTENSIVE AMOUNT OF PREPACKAGED VACUUM SEALED FROZEN FOOD INCLUDING FISH AND DUCK WITHOUT A LABEL. [CA] ALL FOOD MUST COME FROM AN APPROVED SOURCE AND ALL PREPACKAGED FOOD SHALL CONTAIN A LABEL WITH THE FOLLOWING:

1. NAME OF THE FOOD
2. CONTENTS OF THE FOOD IE: OZ
3. INGREDIENTS
4. NAME AND ADDRESS OF MANUFACTURER

THE FOOD WILL BE IMPOUNDED.

Inspector Observations: FOUND DISHES INSIDE THE HAND WASH SINK IN THE BACK ROOM. [CA] KEEP THE HAND WASH SINK ACCESSIBLE AT ALL TIMES. COS

FOUND THE PAPER TOWELS OUTSIDE THE WALL DISPENSER IN THE RESTROOM. [CA] KEEP THE PAPER TOWELS INSIDE THE WALL DISPENSER. COS

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: FOUND THE HOT WATER AT THE 3 COMPARTMENT SINK AT 116F. [CA] PROVIDE HOT WATER AT 120F MINIMUM.
