***[CA] A thermometer +/- 2°F shall be provided and correctly located in each hot and cold holding unit containing potentially hazardous foods.***

### Overall Comments:

***NOTE: Per final plan check report, no open food storage shall occur in the non-operational walk in cooler. Observed one of the chest freezers in the walk in cooler with open foods PIC also proposed using part of the walk in cooler as an office.***
