Inspector Observations: In the men's restroom, soap dispenser is empty. [CA] Soap and paper towels shall be provided at all times at handwashing sinks. [COS] Employee refilled soap dispenser.

Inspector Observations: Observed dent on food can (Amy's Lentil Vegetable Soups). [CA] Dented, bloated, or leaking cans shall be discarded. [COS] Employee moved can to the "damaged goods" section in the back storage area.
