This is a follow up inspection to verify that all major violations mentioned on 4/12/23 inspection report have been addressed. Violations have been addressed and found within compliance:

- K21: Hot and cold water available. Hot/warm water has been restored to facility. Water heater has been changed out (like-for like). See measured observations.
- K22: Sewage and wastewater properly disposed. Floor drain has been unclogged and water can flow through it.
- K23: No rodents, insects, birds, or animals. No evidence of live vermin within the food facility at the time of inspection. Pest control reports have been submitted to specialist for review. Recommend having pest control service facility two times within the month until pest have been completely abated. Continue to monitor for any vermin activity within the food facility.
- Recommend ceiling any holes in wall and replacing missing panels on top of the walk in.
