Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Hand wash sink at the nacho bar was obstructed with box of prepackaged sauces. Manager stated that the box was there temporarily as employees were filling orders.

[CA] Handwashing facility shall be clean, unobstructed, and accessible at all times.

[COS] Obstruction was removed.

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Coleslaw maintained in inadequate ice bath measured at 43F.

[CA] PHFs shall be held at 41°F or below or at 135°F or above.

[COS] More ice was added to ice bath.
