Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: There is no soap at the hand sink in the meat department. [CA] Must use soap when washing hands. [SA] A bottle of soap was put next to the hand sink for proper hand washing.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: The employees in the meat department do not have food handler or FSC. [CA] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.

K13 - 3 Points - Food not in good condition/unsafe/adulterated; 113967, 113976, 113980, 113988, 113990, 114035, 114041, 114254(c), 114254.3

Inspector Observations: The glass Gerber containers of baby food were expired a few weeks ago.[CA] Baby food or infant formula shall not be sold or offered for sale after the "use by" date. [CA] The employee pulled them all for return to the vendor.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: Observed boxes of food outside on the floor for sale display. [CA] Food shall be stored at least 6 inches above the floor to prevent contamination. [COS] The employees took them off of the floor and onto plastic containers.

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

Inspector Observations: Observed an unlabeled spray bottle. [CA] Label all spray bottles with the contents. According to the employee there is floor cleaner in the spray bottle.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: The ice cream freezer chest has accumulated debris inside. [CA] Clean and sanitize the soiled inside of the freezer.

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: Observed used wiping towels on table tops. [CA] The used wiping towels must be in sanitizer between each use.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The tile floor in the walk-in refrigerator is missing the grout and has accumulation between the tiles. [CA]Clean and Repair the floor so that water and mildew are not collecting between the tiles.
