Inspector Observations: Observed live cockroaches of various life stages in the following areas:

1. Multiple on the floor and wall below the hand wash sink within the rear preparation room.

2. Multiple on the floor beneath the warewashing machine and on the underside of the drain board.

3. Multiple within the ice machine compressor compartment and within gaps in the ice machines metal flashing.

4. Multiple within refrigeration units rear compressor compartments at the front cook line.

5. Two on the dining room wall at the entrance to the kitchen.

[CA] The premises of each food facility shall be kept free of vermin. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). The food facility shall cease operation of the food facility immediately. The food facility shall remain closed until: there is no longer evidence of a vermin infestation; all contaminated surfaces have been cleaned and sanitized; and contributing factors such as cleaning, repairs, and the elimination of harborages have been resolved.

CLOSURE / PERMIT SUSPENSION NOTICE

Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>10/1/2020</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease.
