Overall Comments:

2nd follow-up inspection for routine inspection that was conducted on 03/26/2026. Health permit was suspended due to cockroach infestation.

Pest control service was provided by Clark Pest Control on 03/27/2026. No live or dead cockroaches were observed during today's inspection. Monitoring traps at the front service area and the back of the kitchen were checked and no cockroaches were found.

Pest exclusionary measures noted on 03/27/2026 report were completed.

- Observed caulking on the underside of the beer tap counter to seal gap
- Observed stainless steel panel installed on the wall where bottle opener is installed
- Observed cove base installed where it was previous missing near beer tap
- Observed caulking installed under the cabinets where the telephone is located
- Hole on the side of the wall under the beer tap has been covered with a metal plate

Health permit for this facility has been reinstated. This facility is okay to operate.

Consult with pest control company and obtain additional services as necessary (outside of monthly maintenance service).

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
