Overall Comments:

Note: Observed a 6 hour TPHC holding time labeled for mini boba pearls held at room temperature. Manufacture information states keep refrigerated after opening. Hold mini boba pearls utilizing TPHC no more the four hours outside of temperature control or provide documentation showing mini boba pearls are a non-PHF.
