Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: No cook did not have a food handler card nor a food safety certificate available. [CA]
Each employee that prepares food must have a FSC or a food handler card.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Observed some bulk food bins not labeled. [CA] Label each one with the contents.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed clean utensils stored in the crack between the counter and refrigerator. [CA]
Discontinue placing knives in this area as it is soiled. Wash and sanitize the knives before reuse.
Observed the ice scoop to be stored in the ice with the handle touching the ice. [CA] Be sure that the scoop handle is stored so that it does not touch the ice.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed encrusted accumulation and potatoes on the floors behind the shelves. [CA]
Thoroughly clean the floors and discard the food items that were on the floor.
