Inspector Observations: boiled potato, pakoras at 70F. items moved to reach in cooler
[CA]properly monitor perishable food using timer, time stamps etc etc when leaving above 41F or below 135F

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

Inspector Observations: no probe thermometer
[CA]obtain an accurate probe thermometer
