## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

**Inspector Observations: The restroom hand wash sink lacked a supply of hot water.**

**[CA] Handwashing facilities shall be equipped to provide minimum 100°F water under pressure for a minimum of 15 seconds.**

**[COS] Hot water supply restored.**

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: Food boxes and beverage crates stored on the floor of the auto shop area.**

**[CA] Food or food related equipment shall be stored in an approved locations. Food shall be stored at least 6 inches above the floor to prevent contamination.**
