Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Hot plate observed in back preparation area without required hood.

[CA] Relocate hot plate under existing hood or remove from facility.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: In front bagel preparation area, multiple butter spreaders were observed stored in crevice of preparation refrigerator and multiple knives were found stored on a soiled wooden shelf.

[CA] Ensure all utensils are properly stored to prevent contamination.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Near bagel bath steamer, waste lines are draining directly into floor sink.

[CA] Ensure a minimum 1 inch gap is provided from the rim of the floor to the end of waste line.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Discoloration of ceiling tiles observed in back preparation area. Several perforated tiles observed.

[CA] Ensure ceiling tiles are maintained in a sanitary and clean condition. Replace perforated ceiling tiles with easily cleanable, approved tiles.
