Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Single use sanitary towels are stored outside dispenser.

[CA] Single-use sanitary towels shall be provided in dispensers; heated-air hand drying device may be substituted for single-use towels.

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Numerous dead cockroaches observed in glue boards in the back area; near delivery door, near cardboard compressor, numerous dead egg sacks observed below rinsing sink. No live activity observed.

[CA] Clean and sanitize areas of dead cockroaches, contact pest control service to reevaluate and monitor activity. repair holes and gaps in structure to prevent pest harborage.
