Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed dead cockroach in kitchen on the insect sticky board trap. Observed gnats in the back storage area. [CA] Discard traps and replace with new. Take effective measures to eliminate gnats and roaches from inside the facility and protect food from contamination.

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

Inspector Observations: Observed spray bottle of cleaner with no label. [CA] Each spray bottle must have contents on it.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: The chlorine in the dish machine tested at 0ppm. [CA] This must be at 50 ppm chlorine. Sanitize in the dish sink as shown at 100ppm chlorine.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: The stove and cooking equipment has encrusted grease throughout and needs cleaning. [CA] Thoroughly clean the cookline.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: The bulk food bins have plastic cups as scoops inside. [CA] Remove them and use scoops with handles and store with the handle not touching the food.

Overall Comments:
