## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: No food safety certificate available. [CA] At least one employee must have a food handler card.**

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Observed the hand washing sink blocked in the corner of the kitchen. [CA] Each sink is to be readily accessible. Move the rack and table over to unblock it.**

**Observed no soap in the dispenser at the hand wash sink. [CA] Refill the empty soap dispenser.**

**Observed no splash guard between the hand sink and the prep table. [CA] Install a divider between the table and sink.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: Observed used wiping towels on the prep tables. [CA] The wiping towels are to be placed in the sanitizer between each use.**
