Comments and Observations

Major Violations

No major violations were observed during this inspection.

Employees lack Food Handler's Card.

[Corrective Action] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.

Inspector Observations:

Broken glass on the sliding door of the butcher's display case. Shards of broken glass may fall into meat.

[Corrective Action] Repair or replace the glass.

Lack of a mop hanger at the mop sink.

[Corrective Action] Install a mop hanger on the wall above the mop sink.

Inspector Observations:

1. Flooring in the walk-in cooler observed damaged.

[Corrective Action] Maintain floor in good condition.

2. Paint peeling on the wall observed under the water heater.

[Corrective Action] Maintain wall in good condition.

3. Missing cove base tile and wall tile between the band saw and the warewash room.

[Corrective Action] Install cove base tile and wall tile.
