## Comments and Observations

### Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Lack of liquid hand cleanser at hand wash sink.**

**[CA] Provide handwashing cleanser in dispenser at handwash stations at all times. [COS]**

### Minor Violations

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations: Boxed liquor stored in restroom.**

**[CA] All food shall be separated and protected from possible contamination.**

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

**Inspector Observations: Toilet paper stored outside of dispenser.**

**[CA] Toilet tissue shall be provided in a permanently installed dispenser at each toilet.**
