Major Violations

No major violations were observed during this inspection.

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Food safety managers certificate has expired. Per manager, they registered for a class next week.

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Measured ham, alfalfa sprouts, sliced cheese at deli prep station (top inserts) at 45F, tuna salad in 2 door upright at 45F. [CA] Maintain potentially hazardous food 41F and below. Place covers on deli items to keep cold or use bags of ice/ reusable ice sheets.
