Comments and Observations

Major Violations

K15 - 8 Points - Food not obtained from approved source; 113980, 113982, 114021-114031, 114041

Inspector Observations: According to the owner the potato salad is made at home.

[CA] Food must be from an approved source or properly documented. The potato salad was removed from sale and the owner will take it back home.

Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed some rodent droppings on the floor under the milk crates. According to the owner they must be old as there is not currently a rodent issue in the facility. [CA] Remove the milk crates and thoroughly clean the floors. Protect food from contamination and continue with the pest control service.


