FOLLOW UP INSPECTION FROM 10/12/22 IN WHICH RAT DROPPINGS WERE FOUND THROUGHOUT THE KITCHEN ON SHELVES NEXT TO FOOD ITEMS, ON THE WARE WASHER AND ON THE FLOOR.

FINDINGS: ALL HOLES AND GAPS WERE SEALED, THE PEST CONTROL COMPANY (CRANE) SERVICED THE FACILITY. THE PEST CONTROL COMPANY IS SCHEDULED TO COME EVERY WEEK FOR A COUPLE OF TIMES THEN EVERY MONTH.

THE SHELVES AND COUNTERS WERE CLEANED AND SANITIZED, PER OPERATOR. THE FLOORS WERE CLEANED. ALL MAJOR VIOLATIONS WERE CORRECTED. OK TO RE-OPEN.

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
