Rubber seal on the left door of the 2 door reach-in cooler (left) at the bar observed in disrepair.

[Corrective Action] Repair or replace the rubber seal.

Inspector Observations:

Broken cove base tiles observed around the walk-in cooler and walk-in freezer.

[Corrective Action] Repair or replace cove base tiles.
