Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations:

Potentially Hazardous Foods in the walk-in cooler were measured above 41 degrees Fahrenheit.

[Corrective Action] Ensure Potentially Hazardous Foods are maintained below 41 degrees Fahrenheit. Operator adjusted thermostat and ambient temperature measured at 42 degrees Fahrenheit after 30 minutes.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations:

Observed foods stored in plastic bags that are not recommended for food storage in the chest coolers.

[Corrective Action] Store foods in food grade bags.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Observed paint peeling and dust accumulation on the ceiling above the prep table.

[Corrective Action] Repair the ceiling and clean dust.
