At the time of re-inspection, no live cockroaches were found in the facility. PIC provided pest control invoices dated 7/6/2021 and 7/8/2021. Per PIC, Bi-weekly pest control services will continue at the facility.

Operator was instructed to continue removing dead cockroaches throughout the facility. Clean and sanitize affected areas. Repair and seal gaps and crevices in the structure to eliminate areas of harborage. Maintain floors and equipment clean and free of accumulated grease and food debris. Official inspection report emailed to the operator.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
