Inspector Observations: Measured 60F water temperature for the combination faucet at hand sink in kitchen. [CA] Maintain a minimum of 100-108 water temperature

Inspector Observations: Raw seafood noted below raw beef in walk in cooler. [CA] Store raw beef below raw seafood. [COS]

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: Lack of thermal test strips to test dishwashers. [CA] Provide and test at 160F plate temperature daily.

Inspector Observations: Personal water bottle noted on baking sheet. [CA] Store personal items in a designated location.
