Major Violations

No major violations were observed during this inspection.

Inspector Observations: No one is food safety certified [CA] One person must be food safety certified by 06/11/24

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: No paper towel in the kitchen dispenser. A roll of paper towel is near the hand sink [CA] Keep paper towel dispenser supplied - Corrected

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Prepared salad cooler at 47F [CA] Monitor temperature and maintain at 41F or cooler

K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: No time marker placed by the thermos with half and half to show the end time for TPHC [CA] Provide time marker for items noted on the TPHC policy

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: No sanitizer Ecolab test paper available [CA] Provide Ecolab test paper and check sanitizer level daily

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

Inspector Observations: Lack a probe thermometer [CA] Provide a probe thermometer and check levels daily.
