Inspector Observations: Observed the beans on the warmer less than 135 degrees F. [CA] They must be held at 135 degrees F minimum. [COS] The beans were brought to boil on the grill.

Inspector Observations: Observed raw shrimp stored above vegetables in the walk in refrigerator. [CA] Store all raw meat, seafood, or poultry below all other foods.
