## Comments and Observations

### Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations:** *Observed the beans on the warmer less than 135 degrees F. [CA] They must be held at 135 degrees F minimum. [COS] The beans were brought to boil on the grill.*

### Minor Violations

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations:** *Observed raw shrimp stored above vegetables in the walk in refrigerator. [CA] Store all raw meat, seafood, or poultry below all other foods.*
