Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Observed the hand wash sink next to the 3 compartment sink to be blocked for use by a step stool.

[CA] Handwashing facility shall be clean, unobstructed, and accessible at all times.

[COS] Hand wash facility made accessible.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Observed the storage of single use food containers on the floor of the dining area.

[CA] Food and food contact items shall be stored at least 6 inches above the floor to prevent contamination.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Observed unused equipment stored at the rear of the facility.

[CA] The premises of a food facility shall be free of litter and items that are unnecessary to the operation or maintenance of the facility, such as equipment that is nonfunctional or no longer used.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the addition of food and single use container storage within the dining area in front of the customer restrooms. Area lacks smooth and easily cleanable floors, walls and ceilings. [CA] Food and food contact items must be stored within an approved storage area. The ceiling, wall and floor surfaces shall be smooth, of durable construction, and of nonabsorbent material that is easily cleanable.

Observed the ceiling above the mop sink and 2 door reach in refrigerator area to be in disrepair.

[CA] Repair ceiling. Ceilings of all rooms where nonprepackaged food is handled shall be smooth, of durable construction, and of nonabsorbent material that is easily cleanable.
