**Inspector Observations: Observed rodent droppings on top of containers of food. Underneath the warewash sink, under counters in front service area, on top of trays in front service area. [CA] The premises of each food facility shall be kept free of vermin. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). The food facility shall cease operation of the food facility immediately. The food facility shall remain closed until: there is no longer evidence of a vermin infestation; all contaminated surfaces have been cleaned and sanitized; and contributing factors such as cleaning, repairs, and the elimination of harborages have been resolved and a re inspection conducted by the district inspector is completed.**

*PIC called and requested a follow up inspection.*

*Major violation has not been corrected. Facility is to remain closed. Pest control reports were still not available for review. PIC requested a second follow up inspection for 5/4/2021 at 9:30am, this second follow up inspection will be charged \$219/hr.*

*Observed prepared food in to go container on counter. Observed customer waiting for food as we were waiting, customer stated they were from doordash waiting to pick up an order. Observed evidence of prepared food in to go containers in kitchen that was not prepared prior to closure of facility. After leaving facility, observed customer leaving with togo containers.*

*Facility is closed due to evidence of vermin.  
Contacted supervisor Michael Cervantes.*

*Clean and sanitize all food and nonfood contact surfaces. Remove all evidence of rodents from facility and ensure there is no evidence of vermin found at follow up inspection.*

*Facility will remain closed at this time and will not reopen until a follow up inspection is conducted.  
Facility is to cease and desist all food sales and operations, including food preparation. Do not remove, cover-up, or relocated red placard. Failure to comply may result in enforcement actions. If a second follow-up inspection is conducted, there will be a \$219/hr charge at a minimum one-hour charge.*

## CLOSURE / PERMIT SUSPENSION NOTICE

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **5/17/2021**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
