On site for follow up inspection from routine inspection conducted on 11/29/23.

Major violation K22 has been corrected.

No observation of waste water in any of the floor sinks or mop sink. Let water run for more than a minute at mop sink and food preparation sink and water was draining properly.

Per PIC, plumber came yesterday to snake all the floor sink and mop sink lines.

Restroom that is located right in front of the kitchen door is being kept locked at the time. Per PIC, repair is still underway and they will keep it locked with a sign on the door. Provide proof of repair to district inspector Jessica Z. once the restroom is repaired.

Restroom to the left side is functioning okay. Water drained properly when PIC flushed the toilet.

Floor sinks have been cleaned and observed employees cleaning the floors.

Facility is okay to reopen.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **12/14/2023**.
