## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: Observed no food safety certificate and some employees did not have a food handler card. [CA] At least one employee must have a FSC and all others must have a food handler card.**

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Observed the paper towel dispenser at the cookline hand sink to not have any paper towels. [CA] Refill the empty paper towel dispensers.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: Observed no chlorine test strips for the dish machine. [CA] Obtain and use the test strips to monitor the chlorine concentration at 50ppm.**

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

**Inspector Observations: Observed no probe thermometer to monitor proper cooking temperatures. [CA] There must be a probe type thermometer for proper cooking temperatures. [COS] A thermometer was provided at end of the inspection. Be sure to use this probe thermometer to monitor proper cooking temperatures.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: Observed used wiping towels stored on table tops. [CA] They must be stored in the sanitize bucketr between each use.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Observed the wall around the dish sink has accumulated black growth on the caulking. [CA] Clean the wall all around that area and replace the black caulk.**
