K07 Proper hot and cold holding temperatures (hot holding): not observed due to closure. Discussed proper holding temperature procedure. Ensure food containers are not overfilled to facilitate proper holding temperatures.

K23 No rodents, insects, birds, or animals: CORRECTED. No evidence of vermin observed after thorough inspection of facility.

Continue to monitor for vermin activity and follow licensed pest control company recommendations.

K49 Permits available: CORRECTED. proof of payment provided for health permit renewal.
