Comments and Observations

Major Violations

K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: One live juvenile cockroach observed at front service area. No contamination of food/food contact surfaces observed. [CA] Maintain facility to prevent entry/harborage of vermin. Maintain professional pest control service.[SA] PIC will contact pest professional pest control services for treatment.

Minor Violations

K04 - 3 Points - Improper eating, tasting, drinking or tobacco use in food preparation area; 113977

Inspector Observations: Uncovered employee beverage found in food preparation area[CA] No employee shall eat or drink in the food prep, food contact storage, or food storage areas, use designated area.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Scoop handles stored in direct contact with food. Scoop at ice machine is improperly stored on top of machine[CA] Store scoop handle in such a way that the handle does not come in direct contact with food to prevent contamination.
